G. TERM OF THE TENANCY

This application is for a Month-to-Month Tenancy, which may be ended by either party as provided by the **Manufactured Home Park Tenancy Act**.

H. Condition and Boundaries of the Site: I/We have carefully inspected the Site and am/are satisfied that the Site meets my/our requirements in every respect. I/We have also inspected the common areas of the park and am/are satisfied with their condition. I/We agree to sign a copy of the sketch plan indicating the approximate measurements of the Site and a list of features of the Site which belong to and are the Tenant’s responsibility.

I. I/We have been given the opportunity to read the TENANCY AGREEMENT and PARK RULES, and agree that if accepted, I/we will enter into the **TENANCY AGREEMENT** prior to occupancy and will always abide by the PARK RULES. In addition, prior to occupancy, I/we will provide proof of ownership of the manufactured home by submitting a copy of the **Manufactured Home Registry Transfer of Ownership form as per Sections 5 or 7 of the Manufactured Home Act**.

J. I/we agree that if I/we fail to provide proof of ownership or fail to enter into or proceed with any of the agreements listed above, no tenancy exists, and the home must be removed from the park forthwith. In addition, liquidated damages will immediately be payable to the Landlord/Landlord's agent, being an agreed pre-estimate of the landlord's costs to re-rent the site.
